

1. Tuition fee is fully exempted for SC/ST & PH students as per MHRD order no: 33-4/2014-TS.III, Dated: 24.06.2016
2. The most economically backward students (whose family income is less than Rs.1.00 lakh per annum) shall get full remission of the tuition fee as per MHRD order no: 33-4/2014-TS.III, Dated: 24.06.2016
3. The other economically backward students (whose family income is between Rs.1.00 to Rs.5.00 lakh per annum) shall get remission of 2/3<sup>rd</sup> of the tuition fee.
4. The Gen/OBC/Others category of students who doesn't included in the above criteria will have to pay full fee.
5. For regular SC/ST students the tuition fee is exempted on production of proof that the student's self or family income from all sources does not exceed Rs.4.5 Lakhs per year. However, this exemption shall not be applicable for sponsored SC/ST students. Further, whose self & family annual income is more than Rs.4.5 Lakhs Per year has to deposit same fee as of general category. (Ref: MHRD 33-4/2004-TS III, Dated: 16.06.2015).
6. The Gen/OBC/Others category of students have to pay the full fee
